



**TERMS AND CONDITIONS**  
**for**  
**SELECTION AND ENGAGEMENT OF**  
**GRASSROOTS FOOTBALL TRAINER FOR MIZORAM STATE SPORTS**  
**COUNCIL – TATA TRUSTS FOOTBALL ACADEMIES IN VARIOUS**  
**DISTRICTS OF MIZORAM**

**Educational Qualifications:**

1. The candidate should be a AIFF/AFC/FIFA License or NIS Diploma holder or Senior Players having represented the District/State Football Team.

**Experience:**

2. The candidate should have a minimum work experience and field knowledge of Football Coaching at least 1 year in Football Training

**Age Limit:**

3. The age of the candidates must be between 18 and 50 years of age on the last date of application. Date of birth as written in the HSLC/HSSLC Certificate or documents as may be accepted by the Council will be used for proof of age.

**Reservations:**

4. The reservation of posts meant for SC/ST shall be applicable. Such candidates shall be required to submit a proof of Domicile in Mizoram.
5. For availing the benefits of reservation, the candidates shall be required to produce Caste Certificate issued by the State Government.

**Selection and Appointment:**

6. Appointment will be made on the basis of preference made / order of preference of the candidate at Sl. No. 13 of the Application Form. Candidate should clearly indicate the district and the location of the **Academy Centre** (List at Annexure – II) he/she wishes to consider for appointment in case he/she is selected. No candidate shall be considered for any other district other than the districts specified at Sl. No. 13 of the Terms & Conditions of the engagement.
7. Documents to be submitted with the application:- Attested copies of i) certificates from Matriculation onwards ii) SC/ST Certificate iii) Birth Certificate.
8. Last date of submission of application shall be **14<sup>th</sup> January, 2022**.
9. Date of personal interview will be intimated to the candidates.

Wide publicity will be done for selection / engagement of Grassroots Football Trainer. Any person possessing above qualification may apply on publication of advertisement.

Selection will be done on the basis of personal interview by the Board/ State Level Monitoring Steering Committee (SLSC) at Aizawl.

TA/DA will be borne by the candidate at his/her own cost.

10. The selected candidates shall be engaged on temporary basis initially for a period of **three (3) months** which will be extendable up to 1 (one) year. The contract agreement/appointment shall be terminated automatically after completion of the engagement period or further extension of the engagement may be granted if the appointing authority felt it is necessary for extension of the engagement.

### **General Terms and Conditions**

11. During the period of contract on engagement as Grassroots Football Trainer, the Trainer shall abide by the rules and regulations governing conduct, as may be made applicable/amended from time to time by the appointing authority.
12. The Grassroots Football Trainer will impart training at selected centres to children of the age between 6 – 13 years
13. The Grassroots Football Trainer will submit monthly progress report of the status of the training to the Single Point of Contact (SPOC)/Co-ordinator and to the Centre Management Committee at the District and Village Council etc.

### **Location:**

14. 60 Centres were identified and selected by the State Level Monitoring Steering Committee (SLSC) within various Districts of the State.

### **Remuneration:**

15. The Grassroots Football Trainer shall be engaged initially on a monthly fixed honorarium of Rs. 6,500/- per month. No annual increment or Dearness Allowance shall be allowed or granted during the terms of engagement.

### **Contract Agreement:**

16. The Grassroots Football Trainer will have to execute a Contract Agreement at the time of reporting to work under the Department for a specified period from the date of engagement as Grassroots Football Trainer.

**Termination of contract :**

17. Engagement may be terminated by the appointing authority if employee is found medically unfit or is found guilty of misconduct or insubordination (refusal to obey orders from the appointing authority)

**Exclusivity of Engagement:**

18. Whilst engaged with the Department, the selected person engaged as Grassroots Football Trainer, will not be permitted to undertake any other employment or engage himself/herself in any external activities of a commercial nature without written permission of the Department. In case the selected person engaged on contract is found to be indulged in any act of contravention of the provisions of this clause, his engagement would be liable to be terminated without assigning any reasons thereof.

**Confidential Information:**

19. The person engaged as Grassroots Football Trainer shall observe utmost confidentiality and secrecy of any and all information received by him or entrusted to him in the course of his engagement. He/She shall at all times, whether during or after the termination of contract, act with utmost fidelity and not disclose or divulge such information.
20. For purpose of this Clause, Confidential Information shall mean any knowledge or information (whether oral, written, visual or otherwise, hard or soft copy) concerning the programme, employees, officers and finances of the Department and TATA Trusts and shall include without limitation, the report, information, advice and recommendation (in whatever form) contained in any feasibility studies valuation reports.

**Discharge Simpliciter and Notice Period:**

21. After engagement as Grassroots Football Trainer, either party can terminate the contract without assigning any reason whatsoever, by giving one month's notice or one month's remuneration in lieu of notice, to the other party.
