Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR(GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. Date of birth as recorded in the HSLC/HSSLC or other documents as may be accepted by the Commission only will be used as valid proof of date of birth.

v) Working knowledge of Mizo language of at least Middle School standard.

Documentary support to proof all eligibility conditions should not be dated later than the last date of application.

7. **Disqualification** :

- i) Canvassing by a candidate directly or indirectly will disqualify the candidate.
- ii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions will be disqualified.
