1. **Name of Post** : **Grade-I of MHS (Super Specialist Sub-cadre – Nephrology)**
2. **Name of Department** : **Health & Family Welfare**
3. **Classification** : **Group 'A' (Gazetted) (Non-Ministerial)**

5. **Pay** : **Level 12 in the Pay Matrix (Rs.78,800 – 1,75,200)**
6. **Eligibility Conditions** :

1) Educational Qualification:

- a) MBBS Degree from recognized university.
- b) Post doctoral qualification in Nephrology.

2) Permanent registration from the Mizoram State Medical Council.

- 3) Age Limit: Candidate must be aged between 21 and 40 years on the last date of application. Upper age limit is relaxable by 5 years for SC/ST candidates. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth will be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority will be accepted.

- 4) Working knowledge of Mizo language of at least Middle School standard.

Documentary support to proof all eligibility conditions should not be dated later than the last date of application.

7. **Disqualification** :

- i) Canvassing by a candidate directly or indirectly will disqualify the candidate.
- ii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions will be disqualified.
