i) Educational Qualification:

Must be holder of Degree in Law of a recognized University.

ii) Age Limit:

He/She must be aged between 18 and 35 years on the last date of application. Upper age limit relaxation will be as per Notification No.A-12011/1/2019-P&AR(GSW) dt.3.6.2019 (published in the Mizoram Gazette Extraordinary, Issue No. 375 dt.10.6.2019) as amended from time to time. For age proof, HSLC/HSSLC Certificates which clearly shows the candidate's date of birth shall be accepted. In the absence of date of birth in such certificates, the relevant documents issued by the competent authority may be accepted.

Provided that the upper age limit in all recruitment rules/service rules for Group 'A', 'B', 'C' and 'D' posts under the Government of Mizoram where upper age limit prescribed for direct recruitment is 35 (thirty-five) years shall be 37 (thirty-seven) years for direct recruitments in various posts under the Government of Mizoram for advertisements likely to be made after the commencement of these rules during the Calendar years of 2023 and 2024

iii) Character Certificate:

Every candidate selected for appointment by direct recruitment shall furnish certificates, given not more than six months prior to the date of the application, from two respectable persons unconnected with his college or university and not related to him testifying to his character, in addition to the certificate which may be required to be furnished from the educational institution last attended by him.

iv) Working knowledge of Mizo language of at least Middle School standard.

Documentary support to prove all eligibility conditions should not be dated later than the last date of application.

7. Examination:

There shall be a Competitive Examination for recruitment to this post and it shall consist of a Preliminary Examination (Screening test), a Main (Written) Examination and Vivavoce/Interview.

The Preliminary Examination (Screening Test) shall consist of objective type question of 100 Marks, out of which 90 Marks will cover General Knowledge, Aptitude, English, Constitution of India, Code of Civil Procedure, Criminal Procedure Code, Transfer of Property Act, Indian Contract Act, Indian Penal Code, Indian Evidence Act, Law of Torts and remaining 10 Marks to test the proficiency in the Official language(s) of the State of Mizoram.

The ratio on the basis of which the Candidates will be called for the Main (Written) Examination shall be 1:10 (for 1 post of 10 Candidates will be called).

8. Disqualification
